Accomplishments - Action Items Completed:

1. Update on Jurisdictional ESG Funding and Projects

- Leone Lettsome reported that City of North Las Vegas received their FY 17/18 allocation amount and are awaiting for the final HUD award agreement
 - o Sub-recipient agreements are being executed
 - o FY 18/19 application process will begin in late August or early September
- Tameca Ulmer reported that Clark County also received their FY 17/18 allocation amount and are awaiting for the final HUD award agreement
 - o FY 18/19 application process will begin in late September or early October

2. **Recruitment**

- NOFA / Consolidated Application Review Subgroup Volunteers:
 - o Consolidated Application Reviewers focusing on community-wide questions
 - Bridget Claridy, Donna Jordan
 - o Project Application Reviewers focusing on eSnaps application prior to submitting to HUD
 - Stacy DiNicola, Leone Lettsome, Annie Wilson

3. **Discussion regarding the NOFA**

- As of the date of the EWG meeting, the NOFA had not been released
 - o It was released on July 14, 2017 with a due date of September 28, 2017
- Local applications remained open pending necessary information from the NOFA, especially on the new TH-RRH project type
- Training on the NOFA will be scheduled after the NOFA release

4. <u>Discussion regarding Reallocation</u>

- Michele Fuller-Hallauer reported that HUD has been emphasizing active reallocation for the past few years.
 - Reallocation is the process to shift funds from existing CoC-funded renewal projects to create one or more new projects
 - o Reallocations can be voluntary or involuntary
 - Involuntary reallocations can occur after an objective review of project performance
 - If HUD reallocates or defunds a project, the CoC might lose that money in their community

- o Reallocated projects can be put in Tier 1
- o HUD's Policy Priorities include strategically allocating and using resources
- o HUD will award more points to a CoC if there is a system for reallocation
- o The EWG believes they need to have discussions on how they would like to see reallocation handled
 - It's difficult for providers to make informed decisions regarding new projects without information on how reallocations will be handled
 - Some communities award extra points to providers that submit voluntary reallocations
 - Historically, the EWG Scoring & Ranking Team would decide reallocations and notify the CoC Board
 - Recommend creating a Data Working Group for future years to better decided community needs
 - Two proposed meetings to discuss this issue:
 - Community Needs Meeting discuss the needs in the community according to data sources such as PIT Count, Analysis of Community Queue, Gaps Analysis, Housing Inventory, Performance Measures & Data Collection, and System Performance
 - o Bridget Claridy and Emily Paulson volunteered to help prepare for this meeting with help from Bitfocus
 - TH-RRH Meeting discuss reallocation for new projects

- Items that are currently "in-progress and on-going":
 - SWAP Tool update
 - o Discussion on creating webinars/FAQ page for providers to access
 - o Update from Steering Committee on when ad hoc groups should be reporting
 - o Assign members to all of the 2017 CoC Process Review Teams
