### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The Rapid Rehousing program is designed to quickly move households who are experiencing a homeless crisis to transition to permanent housing. One of the key elements of rapid rehousing is the philosophy of a "Housing First" model. This offers housing without preconditions such as sobriety or a minimum income threshold or service participation requirements and permanent housing. This methodology is effective for the chronically homeless with mental health and substance abuse disorders. The best practice model used to develop the project is the Help Hope Home initiative included in the Southern Nevada's Regional Plan to end Homelessness. We use that model to plan for outcomes and success. We work to house participants within a short period of time and then through case management, equip them with the tools that they need to move toward sustainability. Eligible financial assistance includes: 1) Rental Assistance, 2) Rental Arrears if necessary, 3) Security Deposits, 4) Utility Deposits, 5) Utility Payments, 6) Moving Assistance. Intense case management is applied through this program along with supportive staff to adhere to HUD's guidelines of best practices. Staff is responsible for insuring all data is entered into The HMIS system. HUD has defined baseline standards that are required of any and all organizations (such as Continuum of Care, homeless assistance provided, Veteran service organizations, or other to record, use, or process personal protected information). In order for the rapid rehousing program to provide a responsible and professional service to participants, it is necessary to have a working knowledge of referrals, landlord/case manager relationships, attend mainstream meetings monthly, and an overall collaboration with community partners. Another practice which best equips the participant is to help him or her identify barriers which can be addressed through an individual housing plan, and budgeting. Case manager/ Client participation is an agreed upon process where both the case manager and the participant develop a working relationship. Through this model, the previous 5 years of working with programs to either prevent, and or rapidly rehouse participants has shown evidence that around 80% of the participants achieved the goal of remaining permanently housed.
