Accomplishments - Action Items Completed:

- Co-Chair Change: As Ariana has left CCSS, Karen Schneider and Jason Schwartz have agreed to serve as co-chairs of this group.
- Betty Jeanne Apartments has received their Certificate of Occupancy; however, they are not yet accepting applications. They expect to move into the office portion of the property early in the month.
 - There are a few candidates from UNLV/Mojave that can be considered for Moving On for the Betty Jeanne Apartments; flexibility on potential barriers to application approval will be discussed. A request for Moving On candidate referrals from case managers will be made again to the community.
- There are two sets of Policy & Procedures being drafted by members; one for the work of the Moving On working group and the other for the Moving On initiative.
- There are two strategies for proposals for CCHIP Funding for consideration being drafted by members. Knowing that the absence of case management has been a barrier to engagement of landlords willing to work with Moving On clients, the first strategy is a scope of work to contract a client navigator which will provide light-touch case management to Moving On clients. The second is a work in process, which includes the development of a subsidy table to project the amounts needed to provide shallow subsidies to Moving On clients.
- To evaluate future success of the Moving On initiative, members are developing measures that could potentially be used, drawing from the CSH Moving On Toolkit, as well as assistance from the assigned technical assistance provider, who is gathering samples from other communities.
- Group members will be working on a Process Map as a visual aid to show the client flow of Moving On.
- A proposal is being submitted to the Steering Committee to change the group name to the Moving On Leadership Team. Efforts will be increasing to engage vital community members to the team.
