#### Data

- On any given night in Southern Nevada, there are approximately 979 unsheltered unaccompanied youth and children
- Between Emergency Shelter and Permanent Housing there are only 218 beds available satisfying only about 22% of need (2019 Annual Homeless Assessment & HIC Report)
- For every 10 youth experiencing homelessness, less than 3 would get a bed.

The Southern Nevada Youth Action Board, Young Adults in Charge, was introduced to AB 363 while in draft form and provided input at weekly meetings to ensure the policy reflects a true youth focus.

Many of the barriers that youth experience when in homeless situations, can stem from little or no access to any form of identification. These barriers may include access to medical care, education, employment, and the overall convenience of being able to provide identification when prompted. In order to obtain these documents, one must be able to navigate a system of agencies that inherently expect payment for the services they provide. Most youth experiencing homelessness do not have a way to pay for a birth certificate that is needed to then go pay for an ID, driver's license, and driving testing fees. Without these documents, youth face barriers to basic services as well as educational and employment opportunities that allow them to enlist in building a positive life for themselves.

The passing of AB 363 would mean that youth would have an easier time obtaining essential documents by removing barriers in an otherwise difficult and complicated situation. Ensuring that a licensed social worker or the local school district's McKinney-Vento Liaison can provide proof of homelessness for youth, gives agencies the validity of a youth's situation and establishes legitimacy of their current

Passing this bill will also aid in the long process of obtaining records, especially if the youth has a complicated life situation. For example, a member of Young Adults in Charge moved across the country from Tennessee prior to moving to Nevada. While he had an out of state photo I.D., he unfortunately misplaced it while moving, and due to this situation, when he moved to Nevada, he experienced difficulties enrolling into college and gaining employment. He missed two employment opportunities and was delayed in enrolling into school, without knowing what to do or who to talk to for help. He later on found out that he had to contact Tennessee to receive a replacement I.D., a process with a long waiting period while he was fast-approaching his enrollment deadlines. Luckily, he was able to receive help from a case manager to obtain these vital documents but it was no easy task, requiring him to write a letter of appeal, contact Department of Public Records, contact the hospital in which he was born, and much more In the end, he received the correct documents for his I.D. card, but this process could have easily been avoided if a policy like AB 363 was enacted.

Eliminating the struggle to obtain vital records for homeless youth will not only give them access to health care, education, and employment opportunities, but it will reinforce their determination to exit their homeless situation. Life has many trials and being a homeless youth without access to vital documents makes it all the more difficult to navigate. Youth cannot successfully sustain themselves with the necessities of life in the absence of these vital documents. In turn, the community struggles as homeless youth are unable to grow into the roles of their predecessors.
