Agenda Item 1. Call to Order, Notice of Agenda compliance with the Nevada Open Meeting Law.

The meeting of the Southern Nevada Homelessness Continuum of Care Board was called to order at 2:00 p.m. on Thursday, June 8th, 2023, via WebEx.

Agenda Item 2. Public Comment.

No comment was posed to the Board.

Agenda Item 3. Approval of the Agenda for June 8, 2023; for possible action.

A motion was made to approve the agenda. The motion was approved.

Agenda Item 4. Approval of the Minutes from the May 11, 2023, meeting; for possible action.

A motion was made to approve the minutes. The motion was approved.

Agenda Item 5. Presentation and discussion on the evaluation of Coordinated Entry by U.S. Housing and Urban Development (HUD) Technical Assistance Providers and Lived X Consultants; for possible action.

Katie Peterson and Ashley Barker Tolman, HUD Technical Assistance Providers, shared a presentation on the evaluation of the Coordinated Entry System (CE) to the Board. In January 2023, the Continuum of Care (CoC) Board approved a recommendation from the Ad-hoc Governance Working Group for HUD TA to conduct a review of the CoC. This review includes 5 components: The CoC Board Purpose and structure; CoC Working Group and Committee structure; Collaborative applicant roles and responsibilities; data and HMIS lead roles and responsibilities; Coordinated Entry (in partnership with Lived X Consultants. Guiding principles include the following: person centered systems and practices; equity; housing-focused; transparency in community; inclusivity and diversity of perspective; data-informed; action-oriented. The purpose of the Coordinated Entry review is to gather community input, understand the data and outcomes, and elevate recommendations for improvement. By conducting this review, the team hopes to create a stronger coordinated entry system foundation and make immediate improvements for people experiencing a housing crisis. The methodology for

this review included a community survey that received 32 responses from individuals with diverse perspectives and roles. A focus group was conducted with people actively accessing the system such as clients, frontline managers, supervisors, and work group and task force participants. A quantitative data analysis primarily looking at HMIS data was performed, and an access point secret shopping review was conducted at 11 sites advertised on the CE system flyer on the Help Hope Home website. Quantitative data shows that between July 2021 and December 2022 the community completed 13,830 assessments. During that same time there were 1,689 total permanent housing placements. About 1 in 8 assessments performed resulted in a referral with housing placement. Of all sheltered people enrolled in HMIS FY 2022, 63% were first time homeless. During the secret shopping review, not a single person received the real-time help they needed, and only 2 of the 11 secret shopper experiences included completion of a housing assessment. According to the 11 secret shoppers, access points felt more focused on the process than real-time needs and resources. Access point communication about what to expect received a community score of 1.9 out of 5. How the person accessing supports was made to feel received a community score of 2 out of 5. Recommendations from HUD TA team include designating a neutral and trusted Coordinated Entry Lead Entity. The CE Lead Entity should oversee activities associated with Access, the Assessment Process, Prioritization, Referral and Community Queue management. Funding and implementation of Housing Problem Solving should be system-wide so that interactions with people accessing the system begin with a conversation about what they need right now and lead to people with fewer barriers being quickly diverted or rapidly exited. Establish standardize expectations, messaging and supports of system access points. Establish a priority pool of the people on the community queue who will likely receive a housing referral within 60 days, and host regular case conferencing focused on keeping prioritized people located, document collection, housing preferences and barrier reduction. Finally, revise the housing assessment tool to a condensed trauma-informed set of critical questions, used for prioritization.
