Accomplishments - Action Items Completed:

- Funding Opportunities
 - The CoC competition is underway, and applications are being reviewed for scoring and ranking. The FYSB forecast for SOP, BCP, MGH, and TLP will be released in spring 2024. NV Energy is accepting applications for grants (\$2.5-10k); the cycle 2 deadline is on October 31, and awardees will be notified of their status on the week of December 4.
- YWG Coordinated Entry Recommendations Update
 - At the last YWG meeting, members discussed feedback from the HUD TAs and Lived X Consultants and developed a memorandum of recommendations for coordinated entry. These recommendations were submitted to the co-chairs of the CoC Board, Coordinated Entry Working Group, and HUD TAs. The HUD TA shared that access to the top 20 youth on the community queue may be available upon request, as the Adults Without Children and Families coordinated entry subgroups are currently reviewing these lists during their newly formed care coordination meetings. The YWG discussed this idea and expressed favorability, highlighting that the Street Outreach Program team and care coordination meetings would be helpful for tracking down hard-to-reach youth. The YWG also discussed the idea of restructuring the youth care coordination meetings from daily calls to weekly meetings to review the top 20 list and including youth outreach workers and additional youth providers in these meetings; referrals would continue on an ongoing basis. Melissa Jacobowitz will respond to the HUD TA's email regarding accessing the top 20 list of youth on the community queue and propose a time for arranging weekly care coordination meetings.
- Youth Action Board Update
 - Earlier this month, Nevada Partners hosted a youth listening session for youth interested in joining the youth action board to discuss their needs. On August 25, Nevada Partners will host a youth action board meeting. The youth action board currently has 15 youth who have expressed interest. At the next meeting, youth action board members will review handbooks and determine which rules they would like to adopt. Nevada Partners shared that the youth action board will be a two-year program. Youth action board meetings will take place on the last Friday of the month at 3:00 p.m. Nevada Partners will share more information with the YWG members later to help with recruitment efforts.

- Open Discussion
