Agenda Item 1. Call to Order, Notice of Agenda compliance with the Nevada Open Meeting Law.

Agenda Item 2. Public Comment.

Agenda Item 5. Educational session by HUD Technical Assistance (TA) on equity; for possible action.

Ashley Barker Tolman and Alissa Parrish, HUD Technical Assistance, shared a presentation on Equity (Gatekeeping). Gatekeeping is the activity of controlling, and usually limiting, general access to something. Within the context of homeless service work, gatekeeping often includes withholding information that would be considered necessary to make informed, inclusive, and transparent decisions. Gatekeeping also includes withholding decision-making and power. Whether intended or not, those who work in Homeless service, serve as agents of social control, holding power over people in poor communities rather than always engaging with communities in ways that restore decision-making power and establish mutual accountability. Although the intention is to be accountable to populations most impacted, agents of social control are accountable to institutions that fund, credit, and evaluate those in homeless services, and ultimately decide whether to promote or fire agency staff. Gatekeepers often find themselves trapped and conflicted. It is through working from an anti-racist framework, embodying anti-oppression values, and being accountable to communities most impacted that agencies become "liberated gatekeepers" recognizing the power and influence to become agents of transformation.

Agenda Item 6. Discussion and approval to remove open meeting law requirements for future meetings; for possible action.

Co-Chairs Shalimar Cabrera, Social Service Provider, U.S. VETS-Las Vegas, and Meg Pike, Education, Clark County School District, presented to the Board for discussion, the removal of Open Meeting Law. The Board voted to remove Open Meeting Law requirements for future meetings. The Executive Committee will work on outlining future meeting processes and will present at the November Board meeting.
