Feedback: Applicants, Working Groups, and Board Members

- Overall feedback was generally positive
 - All involved do their part and are dedicated to a meticulous process.
 - The new consulting team was a breath of fresh air.
- Specific examples will help us refine the process next year
 - Start earlier in the year
 - More marketing and outreach to bring in new projects and community supports
 - Clearly defined use of utilization of beds & funds as part of monitoring process
- Recommendations also related to our system overall and awareness of items that support/weaken the overall score
 - Coordinated Entry system design causes bottlenecks in the system
 - More robust supportive services, including recovery services, would help clients exit programs to self-sufficiency instead of returning to homelessness

Recommendations from EdeColigny Consulting, LLC related to the application process

Board Engagement

• In developing and informing how projects are prioritized, reviewed, and scored

Timeline

- Starting earlier in the year will allow for stronger application tools, monitoring scores, and collaboration
- Work with prospective new applicants and provide intensive technical assistance to improve quality of submissions
- Ensure all materials are clear, focused, and support the competition

Recommendations from EdeColigny Consulting, LLC for a more competitive application and stronger CoC

- Use NOFO results to drive CoC priorities
 - Establishing a PSH preference with SNHRA. Set it as a goal even if it takes multiple years to achieve.
- Improve program performance to improve overall CoC system
 - Establish goals related to performance measures and then provide training, technical assistance, and support
- Address low-hanging fruit
 - Offering annual SOAR and MPBT training; regular updates to CoC-wide policy
- Overhaul the project monitoring process
 - Ensure that feedback leads to improvements at the project and system level
- Take action now
 - Potential areas for improvement may be multi-year endeavors
 - Build a workplan with interim goals, action steps, and milestones

SNH CoC Process Strengths

- Inclusive, transparent governance and annual process
- Increased the number of RRH units to 1,683
 - Important to maintain these units
- Maintaining non-congregate shelter options
- Conducted a racial equity assessment in 2020/2021
 - HUD recognizes assessments done within the past 3 years
- Local competition is fair, equitable, engages new partners
 - Scoring includes objective criteria, considers system performance measures, and includes reallocation of lower performing projects

SNH CoC Process To Do List

- Finalize the Emergency Transfer Plan and Quality Practices
- Annual updates of CoC-wide antidiscrimination and other policies
- Work with SNRHA to establish a Moving On Preference
- Ensure homelessness is not criminalized in Southern Nevada
- Offer annual trainings and promote SOAR certification
- Improve data quality through training and technical assistance
- Improve system performance measures through technical assistance
- Provide technical assistance to potential applicants 3 6 months prior to NOFO, especially those who are able to leverage housing and healthcare
