- **Updates from the Veterans Administration**

- **Homeless Census Unsheltered Count: January 25th**

 - Jaycee Park, 2100 E. St. Louis, near Eastern and Sahara
 - About 50 people, in MORE Team jurisdiction so contact them for further follow-up
 - Vacant Lots at 2200 W Evans Avenue, North Las Vegas
 - Code enforcement issues regularly out there
 - About 40 people
 - Charleston & Honolulu—moving to Sahara and Sandhill and will be performing a Level 1 outreach on December 19th
 - Location of the murders and HOSN has been out there since the situation
 - One of the shooting victims is only person that wants to be housed
 - Fentanyl use is heavy
 - HOSN, Vegas Stronger, Foundation for Recovery, SNHD, possibly Next Step for medical
