- Training Update
 - Final Documents are available
- Volunteer Recruitment
 - [SignUp.com](#) is now active for County and North Las Vegas sites
 - County recruitment of Outreach Teams and CoC Providers
 - Updates from Leads for Each Jurisdiction
 - City of Henderson: 52 volunteers – all internal
 - Clark County: 22 signed up
 - U.S. VETS – 17 staff and will recruit client navigators closer to the date (request for 20 gift cards)
 - VA: 28 volunteers – not registered yet
 - Anyone with lived experience who wants to help – they can get a \$50 Walmart gift card.
 - CNLV: 12 volunteers.
 - CLV: 50 volunteers – all internal; all tracts distributed; training next week; all materials are printed out.
- Youth Count
 - Determining areas for coverage
 - Outreach Data – Alyssa provided outreach data of where youth are most frequently found and made recommendations for youth specific coverage.
 - Compare with data from last PIT count. Overlay with tract maps to identify specific hotspots for youth. NPHY will review and get back to Alyssa.
 - Survey
- Survey and Mapping Reminders
 - Jurisdictional Maps are available for pick-up
 - NLV picked up; LV printed out their own; Henderson has theirs
 - Marisa & Lou to coordinate with Catherine
 - Tract Maps are available in the shared drive.
 - Included excel spreadsheet with drivable miles
 - Geographic Focus Areas are listed as hot spots on each map
 - 911 Data from Fire Departments
 - Data from Outreach and Public Works Teams
 - Survey 123 should be downloaded when entering data for the count
 - Incentives of bus passes will be provided. McDonald cards are not available.
 - Important to get as many surveys done as possible which will assist with extrapolation formulas. The more surveys there are the more accurate the count will be.
 - Many communities have moved away from observational counts and only use data for people they communicate with. This impacts data quality and ability to deduplicate data. Not sure what is included in HUD reports.
 - Could have missing data (e.g. TAY ages 18 -24) if it's not asked for in survey.
 - Last year 65% were not able to be surveyed; 55% of able to be counted
 - Add to the survey – Consider adding an additional observational question: how many people appear to be between ages 18 and 24 at this site. The other questions have logic behind them. Consider providing training on how to do the observational portion of the survey. Is there a way to determine age based on a process?
 - Suggestion to do survey as we've done it in the past and then start Feb 1 to collect data in a more robust way that separates out youth / young adult under age 24.
