CE Interim Prioritization & Assessment Process Update

May 2024

A bit of history...

HUD TA and the Lived Experience Consultants performed a Coordinated Entry Evaluation in 2023 which included focus groups and a "Secret Shopping" component to evaluate how persons experiencing homelessness were being served and connected to housing programs in the current Coordinated Entry System.

What was learned:

- CHAT tools are long, duplicative, not trauma informed, and largely do not result in housing placements. There was broad community support to replace the CHAT suite of tools.
- Persons were being enrolled into Coordinated Entry by providers and there was a common perception that this leads to housing placements, yet HMIS data suggests that roughly 1 in 8 people who complete the process receive a housing referral through Coordinated Entry
- The overall assessment process lacked a human centered, trauma informed approach, lacked connection to community resources and services, and did not center or empower people experiencing homelessness in their efforts to self resolve their housing crisis.

Development of the Short Term Project Team

- The CESWG voted to prioritize updates to the Prioritization Policy and Assessment Process in 2024. They formed a Short Term Project Team of 9 members to develop an interim prioritization process, supported by an updated assessment process that would address the gaps and inequities of the current coordinated entry system.
- Representation within Short Term Project Team:
 - 89% of Short Term Project Team have lived experience of homelessness in lifetime; 38% of lived experience of homelessness in the past 5 years
 - 75% of Team are currently in Frontline positions
 - Intentionally included representation from veteran, youth and young adult, and domestic violence systems
- Weekly meetings in January-March focused on:
 - o Reviewing existing qualitative and quantitative data
 - o Discussing team experience on frontline (who is currently being missed by the process)
 - o Discussing community examples
 - o Defining "Vulnerability" and
 - o Narrowing down the vulnerability factors for the Interim Prioritization Policy
 - o Developing the assessment process to support the CESWG-approved Interim Prioritization Policy

Short Term Project Team Commitments

- Commitment to leading with racial equity
- Vulnerability is defined as "who is least likely to be able to exit homelessness on their own"
- Commitment to developing a continuous improvement process to ensure ongoing Prioritization Policy data analysis and identification of necessary policy adjustments

Example: expecting Long Term Project Team to look at prioritization and housing placement data quarterly; if the interim policy is causing harm, it needs to be immediately adjusted.

Interim Prioritization Factors and Weighting

Vulnerability factor	Points Assigned / Weighting System	Connection to Vulnerability "Who is least likely to be able to exit homelessness on their own"
Legal involvement Defined as felony or violent crime	1 point	Higher barriers to getting housed and employment
Pregnant and/or parenting households	Up to 2 points total 1 point for pregnant; 1 point for parenting or have a dependent over 18	Pregnant = harder to get employment Parenting a child(ren) under 18 or parenting an adult with a disability = harder to get employment due to childcare, transportation issues getting children where they need to go, higher cost of living
Tri-morbidity Defined as chronic health condition, mental health diagnosis and substance use disorder	 point possible for each of 3 factors chronic health condition mental health diagnosis substance use disorder points = tri-morbidity 	Significant health related conditions and/or disabilities make it harder to exit homelessness on one's own. More conditions means more difficulty exiting homelessness on one's own.
Aging Defined as 55+	1 point	Health conditions are more severe in conjunction with experiencing homelessness, especially long term homelessness. Average life expectancy is lower for people experiencing homelessness.



If yes, do you want services that are specifically designed to help people who've experienced violence and/or intimidation from a family member, intimate partner, or someone else?

Where did you stay last night / will tonight?



- Do you have any chronic health conditions that impact your daily activities? Chronic health conditions typically last one year or more and require ongoing medical attention.
- 2) Do you have any mental health challenges that interfere with your life or impact your daily living?
- 3) Do you feel you have an issue with addiction of any kind? That means you often feel you're unable to control your use of alcohol or other drugs.

Do you have your own vehicle?

Do you prefer to be located near public transportation? Do you have any needs when it comes to the physical layout of your home - things like no stairs, an accessible shower?

When it comes to identification, what do you currently have?

Some programs require that households have legal residency in the United States. Do you have legal US Citizenship status?

Is there anything else you want me to know about your preferences on where or how you live?

Long Term Project Team Development & Goals

- 4 members of the Short Term Project Team were grandfathered into the Long Term Project Team for continuity.
- 6 Additional members who completed an application of interest were added to the Long Term Project Team. No vote was required by the CESWG as there was room for 10 members.
- The focus of the Long Term Project team is to continue the work of the Short Term Project team by monitoring the CE Interim Prioritization & Assessment Process via examining data and receiving community feedback. They will oversee improvement of the process as needed prior to adjustments, refinement & final launch in December 2024.
- The Coordinated Services Committee will receive regular updates and have discussion regarding learning between June-November 2024.

Overarching Goals of Interim CE Prioritization & Assessment Process

- More accurately identify "the most vulnerable" households for limited supportive housing resources
- Create a more human centered and trauma informed process that centers people's natural strengths and supports, introducing a more relational approach to the assessment process
- Collect only what data is necessary, at the time within the process that the data is relevant
- Include Housing Problem Solving conversations to help people resolve their housing crisis when possible and connect to critical community resources
- Important note: Many people will not receive housing as a result of being placed on the community queue. There are roughly 7 supportive housing (RRH&PSH) openings per month in Southern Nevada. This new process will not solve the lack of supportive housing availability; this new process intends to better connect people to resources in real time (HPS), and prioritize the most vulnerable people for very limited supportive housing.
