# Agenda Item 5. Presentation on the CoC Monitoring report and next steps provided by EdeColigny Consulting; for possible action

The 2025 Continuum of Care (CoC) Monitoring Report was presented to the CoC Board on October 8, 2025 by EdeColigny Consulting. The presentation provided background on the new monitoring program and outlined how national shifts have influenced local priorities. System level findings identified the need for a stronger housing focused approach, increased trauma-informed practices, and additional technical assistance and training to support compliance. Recommendations emphasized advancing evidence-based practices, enhancing housing orientation, and strengthening compliance focused training and support. The presentation concluded with key considerations and next steps for system improvement. The Board will continue to discuss the results of the monitoring report at the October 22<sup>nd</sup> meeting.

The Board convened a special meeting to discuss the strategic plan. Members divided into groups aligned with specific goals and objectives, and each group presented an outline detailing strategies for achieving those goals.
