

Good afternoon current recipients of CoC funding through the SNHCoC.

As you are probably aware, a recent federal court order has required HUD to withdraw the FY 2025 NOFO (issued in December 2025) and re-issue the FY 2024-2025 NOFO that was originally released in July 2024. HUD was further required to announce a process whereby all eligible renewals may submit a request for FY 2025 renewal funding.

On January 8, 2026, HUD issued an update relating to the 2025 NOFO process and on January 9, 2026 they re-issued the 2024-2025 NOFO with all its original language. On January 8, 2026, HUD issued an update regarding the FY 2025 NOFO process. On January 9, 2026, HUD reissued the FY 2024-2025 NOFO in its original form, without changes to the language. Through these communications, HUD has indicated that E-SNAPS will open January 16, 2026, and at this time, more guidance will be available. Applications will be due to HUD February 9, 2026. HUD expects to announce awards no later than March 2026.

Since we are now operating under the terms of the FY 2024-2025 NOFO, local applications submitted to CCSS by the December 18, 2025 local deadline no longer apply at this time. This includes any applications for transition grants or any requests to fully or partially re-allocate an existing grant. This also means that projects awarded in the FY 2024 competition and current SNOFO grantees have the opportunity to renew their grants.

Current grant recipients have the following options for how to proceed:

- Grant recipients that received a grant award in FY 2024 may request renewal of their grants at their current budget as reflected on the 2025 Grant Inventory Workbook (GIW). Grantees do not have to submit an application in E-SNAPS. HUD will issue additional guidance on how grantees may request renewal.
- Grant recipients that did NOT receive a grant award in FY 2024 must submit a Project Application in E-SNAPS to request renewal at the same budgeted amount listed on the 2025 GIW. This will apply to any recipients of funding through SNOFO. The Project Application will be available in E-SNAPS no later than January 16, 2026 and will be due by February 9, 2026. It is not clear whether these applications must be scored and ranked by the CoC.
- Applicants in either of the above categories that choose not to renew have the option to voluntarily re-allocate their funds to a new grant. This could be either a transition grant or an entirely new project. Note that under the FY 2024-2025 NOFO, the only eligible new project types are Permanent Supportive Housing (PSH), Rapid Rehousing (RRH), Joint Transitional Housing/Rapid Rehousing (TH-RRH) and Coordinated Entry (CE-SSO). This means that transitioning from permanent housing to Transitional Housing (TH) or Supportive Services Only (SSO) is no longer an option.

Considerations for current grantees:

- Since the original FY 2024-2025 NOFO is in effect, we do not expect that the Project Application in E-SNAPS or the 2025 Grant Agreement will impose any new requirements relating to recent Executive Orders or other new policy priorities.
- We expect HUD to issue a new NOFO for FY 2026 sometime this summer and it is likely to be similar to the FY 2025 NOFO (released December 2025). The cap on Permanent Housing is expected to be retained, along with the priority for new funding for TH and SSO projects. Grantees that renew their funding in FY 2025 will most likely have the option to transition their grants to TH or SSO in FY 2026.

What applicants should do:

- **Inform CCSS by Friday, January 16<sup>th</sup> at 5:00pm whether you intend to renew your current grant for 2025.**
- Please indicate if you plan to renew for the full amount of your grant or if you will be reallocating some of your funds and the amount you will be renewing for.
- If you do not intend to renew your grant, advise CCSS of your interest in pursuing a transition or re-allocation grant. Note, again, that new grants can only be PSH, RRH, TH-RRH or CE-SSO.
